REMINDER-II

Sub: - Request to grant regular promotion from TES Gr B to ITS Gr. A -Case of
Shri M. D. Chaudhari, Retd. SDE Valsad (Staff No.19096).

Ref: - Our letter of even number dated 16.06.2021.

Respected Sir,

1. With due respect, we write to invite your kind attention to our letter No: BPS/ BDPA(I)/MDC/VLD/ 2020 dated 24.12.2020 & 16.06.2021 on the captioned subject wherein we had forwarded the representation received from Shri M. D. Chaudhari, Retd SDE Valsad dated 25.01.2019 and 12.12.2020 regarding grant of his due promotion to ITS Gr. A from TES Gr. B. enclosing necessary documents.
2. Sir, we regret to write that though one year time is nearly over, we have not received any reply/communication from your office and the Pensioner is pressing hard to have reply to his representation. We once again forward his case, with following remarks.
3. In this regard, it is submitted that officer was working in Surat SSA and he was given local officiating promotion to ITS Gr A and posted as DE Vapi for 179 days from 08.02-2000 and his pay is fixed as DE by AO (cash) GMTD Valsad vide memo no. A-6/ Pay fix/ 98-99/ 93 dated 12.07.2000.
4. On completion of 179 days, he was reverted for one day and again he was re-promoted on the same post for 179 days. In this way, he worked in the cadre of ITS Gr A from 08.02.2000 to 29.03.2001.
5. There after he was not given either officiating or regular promotion in the cadre of ITS Gr. A due to pending court case no. 37/2001 in CBI Court, Ahmedabad.

6. His case was finalized and he had been acquitted on 03.05.2016. There after he has been absorbed in BSNL and P.O. No. GJT/VALSAD/TES/GR. B-List-29/I/2017/1124 dated 26.08.2017 and **he got all pensionary benefits including regular pension.**
7. **Being eligible for** time bound and regular promotion in the cadre of ITS Gr. A, he is representing his case since long but no action is being taken at your end which creates dismayed situation for the Officer.
8. For your information, Shri M. D. Chaudhari is belonging to ST category and he was working in the cadre of TES Gr. B since 23.07.1994. His seniority no. is 14238.1 as per seniority list published by CGMT Ahmedabad vide O.M. No. Staff-13-1/ Seniority/ 2001/10 dated 17.05.2001.
9. In view of above, it is requested to look into the matter in person and forward the case to the competent authority for extending benefit of time bound promotion to him and cause justice to the aggrieved pensioner; at the earliest.
