Kindly refer to this Association's letter of even number dated 14.03.2022 and 16.04.2022 on the above subject and intimate the terms and conditions under which the BSNL IDA pensioners have been asked to submit their option for FMA. Without knowing that terms and conditions the BSNL IDA pensioners are not in a position to give option.

Kindly therefore, clarify the following doubts to make it clear to the BSNL IDA pensioners before submitting the option called for.


- 1) For grant of FMA to IDA pensioners i.e. BSNL Pensioners through CPMS is it necessary to surrender BSNL MRS identity card?
- 2) If the BSNL MRS card is surrendered how the BSNL pensioner will take treatment as impatient in the BSNL empanelled hospitals and claim reimbursent therefor.
- 3) Whether the amount of FMA to BSNL IDA pensioners is debitable to the consolidated fund of India along with pension or is it to be recovered from the BSNL by the DOT.
- 4) For drawing the FMA along with pension is it necessary, the BSNL IDA pensioner to become member of CGHS by paying CGHS contribution or

can continue to avail impatient treatment facility under BSNL MRS scheme.

We hope that you will issue necessary clarifications without any more delay.
