Dear Brothers,

You all are aware that 7th C.H.Q. Working Committee Meeting was held on 25th & 26th April, 2022 in Ahmedabad to take stock of organizational issues and place before them brief accounts of various activities under taken by CHQ during the **pandemic** period and simultaneously to know the organizational position of the Associations in all Circles. Brief report of proceedings is already published in our April, 2022 issue of BSNL Pensioners News.

After hearing all the participants it was felt that there is urgent need of strengthening our Association numerically and financially in all the Circles and Districts. It was decided to organize Membership Enrolment Drive from 16th June to 15th July, 2022 throughout the country.

It is, therefore, requested that all concern may take note of the decision and move in the field to enroll maximum members by visiting their houses and also listening their grievances as well. Those Pensioners who have joined other Pensioners Associations can also be enrolled as member in our Association.

Further, a copy of draft Memorandum addressed to Hon'ble Prime Minister Shri Narendrabhai Modi requesting to consider our "Request for finalizing revision of pension from 01.01.2017 for BSNL – IDA Pensioners as per 3 P.R.C. Recommendations – Delinking it from Wage Revision of Working Employees" is also enclosed herewith. You may take required

copies and obtain the signature of members and also new members as well and post it directly from your end.

On publication of Gazette notification on 23rd December, 2021 publishing latest C.C.S. Pension Rules 2021 replacing C.C.S. Pension Rules 1972, it has been made possible to Revise the Pensioners by the Govt. itself and now a new way is paved and doors are opened for our Pension Revision.

But let us admit that it will never be an easy task and we will have continue our struggle more forcefully involving maximum number of Pensioners and Pensioners Associations as well. For this, we have to make our efforts to focus attention of Government by such campaigning.

Meeting with Local M.Ps and requesting them to forward the Memorandum with their recommendation will help us to yield results.

We, therefore, request you to move with vigor and force in the field to enroll new members and also get maximum signature of pensioners in our Memorandum.

We also request you to acquaint our members that we have purchased our own office in CHQ and functioning regularly to serve you more and represent the general grievances of BSNL Pensioners to competent authorities. Now we have to incur fiscal expenditure for maintenance of our office as we are liable to pay all taxes of various agencies. We therefore request you to kindly collect Rs.100/- per member per year voluntarily and help us to maintain our office with more efficiency.

Your detailed report on initiative taken by you and result thereof will be welcome.
