In this regard, this office has issued letter under reference 1 & 2 for timely processing of medical bills and issuance of BSNL MRS Card.


Most of BAs had processed maximum no. of bills as per ERP record. However, still no. of bills are pending with SSA/BAs for processing and creation of liabilities in ERP for payment. The details of pending indoor/Outdoor bills received from the BAs/SSAs are as per Annexure-I. In this regard it is requested to process the pending Indoor/Outdoor bills punch in ERP for reimbursement by 20.03.2023. Also it is to ensure that "R" block of documents are clear by competent Authority

In respect of Medical allowances, documents may be processed and punching & Posting is to be done in ERP till quarter ending December' 22 by 15.03.2023.

Further it is requested to encourage the pensioner/retired employees to opt for CGHS medical facility for getting cashless medical facility on time.

All BA/SSA Heads are requested to process BSNL MRS Option (with voucher/without voucher) forms submitted by retired employees/Pensioners for further necessary action.


You are also requested to process the pending medical bills and those who have submitted documents for payment of all the retired employees/pensioners for further necessary action.
