BSNL&DOT Pensioners Association (India) Ahmedabad who also happens to be Secretary Bharat Pensioners Samaj, the largest Federation of Pensioners Associations.

Therefore, CCA (Pension) Ahmedabad was requested to share the link in the future and also to share the minutes of Pension Adalat/ Shri D.D. Mistry wanted to have a copy of minutes to share with pensioners, the good work being done through Pension Adalat.

Unfortunately, CCA Gujarat Circle conveyed, that his office does not have any responsibility of sharing minutes of any Adalat with any Association.

Again, for Pension Adalat held on 23.06.2023 link was not shared with Sh. D.D. Mistry nor was any information conveyed. So he could not attend Pension Adalat. But Other Pensioners who went there to participating were not allowed and told that CCA will not send link in future.

Hope CCA (Pension) will adhere to his commitment as per his email dated 26.06/2023 & will also share the Minutes of Pension Adalat.


Our simple request is:

4. To give minutes or brief of the Pension Adalat for settled/Pending cases.
