2. We had forwarded copy of representation dated 22.08.2022 received from Smt. Damyantiben Rajnikant Shrimali, widow of late Shri R.K. Shrimali, TT A.T.D.HR No; 199414541, O/O Ahmedabad Telecom District, Ahmedabad with all required documents.
3. The applicant has submitted death certificate of her husband, copies of Police Investigation Report and other required documents and has requested to consider her case for payment of Ex-Garcia lump sum compensation due to accidental death of her husband on duty and we had requested to look into.
