Respected Madam,

1. With reference to our letter dated 28th December, 2024, the case was discussed in the National Pension Adalat on 29.12.2023. Also in the afternoon, self and R.C. Sharma Treasurer had met you personally and requested to expedite the case of Mrs. Gauriben M. Garasia, Surat. We had informed you that Mrs. Gauriben Manubhai Garasia, Surat, has been paid arrear of pension on 26.12.2023 but her pension is not commenced from January 2023.

2. We are happy to write that she has been paid arrear for October 23 & November 2023 for Rs.50522 on 26.12.2023 and her pension is regularized w.e.f. December 2023 and January 2024 pension has also been paid.

3. Now, the Pensioner's grievance is she has not received her pension arrear w.e.f. January 2023 to September, 2023, total for nine months.

4. She was migrated to sampan on 15.12.2022 and so all the payments have to be paid by your office and CPPC of Nagpur Bank of India has nothing to do with any payment. But for the reasons best known to your office, the issue had been unnecessarily referred to CPPC Nagpur. And on our persuasion they also replied to you. The Pensioner has already furnished her bank statement from the Bank with seal of the Bank, but it has not been honoured till date.

5. We, therefore request you to kindly cause early payment of the arrear to the Family Pensioner.

For your ready reference, we enclose herewith copy of bank account of the Family Pensioner with Bank seal and also proof that she was migrated to sampan on 15.12.2022; and awaiting early action,
