Subject: A request to Expedite to issue Presidential Orders – Case of Sadhu Charan
Kerai, ATT – TSM, O/O G.M. T.D. Jamshedpur.

Respected Sir,

This is in continuation of our letter dated 22.03.2024 on the captioned subject. We enclose herewith a letter from Under Secretary, DoT New Delhi letter No: 01-12/2022-SNG dated 06.05.2024 addressed to your office on the captioned subject. The brief of the case is given below for ready reference.

- A. He was awarded Temporary Status vide DoT – T.D.M. Jamshedpur Memo. No. E-46/Court-Case/Pt-II/4 DATED 17.09.96. (Copy enclosed – Annexure-1).
- B. He worked as R.M. w.e.f. 20.09.1996 to 02.10.2001.
- C. He was appointed as Regular Mazdoor, vide the GMTD, Jamshedpur letter No: E-1/Staff/Corr/28 dated 16.07.02. (Copy enclosed – Annexure-2).
- D. He retired on superannuation on 30.09.2019 as ATT, from o/o GMTD Jamshedpur.
- E. The CCA Ranchi instead of issuing provisional pension, vide his letter dated 31.05.2022 had asked the GMTD Jamshedpur wrote “ Hence, it is the duty of BSNL Authority to issue his Presidential Order so that pensionary benefits may be settled by this office” (Copy enclosed – Annexure-3).
- F. The CGMT & GMTD have written repeated letters to Corporate Office, but till date no action is taken by Corporate Office.
- G. We enclose herewith a copy of the CGMT Ranchi letter No. ST/PO/JKD/2020/Left out case/57 Dated 20.07.2023 addressed to the BSNL Corporate Office, New Delhi requesting for issuance of Presidential Order in favour of Sadhu Charan Kerai, ATT – TSM, O/O G.M. T.D. Jamshedpur. (Copy enclosed - Annexure-4).

Since all the formalities at Circle Level have been completed and the case is in your office, we request you to kindly expedite the issuance of Presidential Order so that the retiree can get his pension, which is pending since the date of his retirement.
