Respected Sir,

1. We write to invite your kind attention against long pending case of one time subscription of CGHS by the Pensioner which is pending in the office of the Chief Engineer, Civil, NTR New Delhi. Required information is furnished below:
 - a) The Pensioner had effected the payment to the CGHS Authorities for Rs.54,000/- (Rupees Fifty Four Thousand only) vide DD No. XAB 540532 dated 28.12.2020 of Punjab National Bank, New Delhi in favour of the Accounts Officer, CGHS, New Delhi (Copy enclosed Annexure-1).
 - b) As required, the Pensioner had surrender his MRS Card No: NTR/0120RC and had obtained certificate from the AGM (MRS) O/O CGM CN (TX-North), New Delhi (Copy enclosed – Annexure-2).

- c) The Pensioner was issued Index Card by the CGHS Authorities enlisting name of Pensioner and his wife on 28.12.2020. (Copy Enclosed – Annexure-3).
- d) Pensioner had applied for refund of the subscription paid by him at detailed in Para a) to his Office on 23.12.2020 (Copy Enclosed – Annexure-4) under clear signature of SDE (P&A) on 11.1.2021 accompanied with copy of his PPO No: 2-1/PC/7740/ppo-5517/2003/Pen (copy enclosed – Annexure-5). 2. Sir, we regret to write that till date even after passing of more than two years period, the Pensioner is struggling to get his legitimate payment and running from Pillar to Post but getting no clue regarding the status of his case.
3. We regret that even the Office Bearers of this Association has personally tried to contact the concerned authorities, but they too are helpless.

We, therefore, request you to kindly take suitable action for long pending payment of the Pensioner.
