In addition to addressing the authorities our Executive President has made several verbal/written representations to concerned authorities and met them in person to yield fruitful solution of the case.

4. Sir, admittedly it is human to err but can never be human not to try to rectify the error, admitting fully that it is an error. To apprise you, we herewith represent woes of the affected pensioner who is suffering fiscally since five years for fault on his side.

A) We enclose herewith a copy of our letter No: BPS/BDPA(I)/MOTISAGAR/2023 dated 1<sup>st</sup> February, 2023 addressed to Dr. Pravin Kumar Purwar, C.M.D. BSNL, Bharat Sanchar Bhavan, Janpath, New Delhi – 110001 on the captioned subject which reads “We regret to write that the Pensioner is struggling since last four years to get refund of his rightful claim of CGHS Refund as the case is pending in the office of the Chief Engineer, Civil, NTR New Delhi. We once again provide you brief for your kind information and with a hope for necessary action in the matter.

B) The Required information is furnished below:

- a) The Pensioner had effected the payment to the CGHS Authorities for Rs.54, 000/- (Rupees Fifty Four Thousand only) vide DD No. XAB 540532 dated 28.12.2020 of Punjab National Bank, New Delhi in favour of the Accounts Officer, CGHS, New Delhi. As required, the Pensioner had surrendered his MRS Card No: NTR/0120RC and had obtained certificate from the AGM (MRS) O/O CGM CN (TX-North), New Delhi.
- b) The Pensioner was issued Index Card by the CGHS Authorities enlisting name of Pensioner and his wife on 28.12.2020 Pensioner had applied for refund of the subscription paid by him at detailed in Para A) to his Office on 23.12.2020 (Copy Enclosed – Annexure-4) under clear signature of SDE (P&A) on 11.1.2021 accompanied
