Sub: Empanelment of CGHS/ECHS Hospitals – Regarding - Blatant violation of Corporate Office Letter No: BSNLCO-ADMN/11(12)/1/2020-ADMN-Part (1) dated 05.03.2024, 05.04.2024, 13.08.2024 and 04.10.2024 – by the GMTD Rajkot District, Rajkot.

Respected Sir,

1. We enclose herewith copy of the GMTD Rajkot letter No: The GMTD Rajkot No: GJRJT-11/21(13)/1/2021-GJRJT-ADMN-HR-LEGAL/DFA/ 1084839 dated 19.11.2024, extracts reproduced below:

With reference to above, it is to intimate that our agreement period of 02 (Two) year is completed on 30.09.2024. The approval for further renewal of hospital agreement with you is not accorded, so it is requested to consider the agreement terminated w.e.f. 30.11.2024 please.


2. Sir, it reads that the further approval is not accorded and the agreement is not renewed **without assigning any reason.**

3. On one side, honoring the requests of the Employees and Pensioners, the corporate office writing to empanel more and more hospitals for CGHS/ECHS, whereas here the available facility is blatantly discontinued by the GMTD Rajkot.
4. Our District Representatives had a meeting with the GMTD Rajkot on 03.12.2024 with written request dated 02.12.2024 (copy enclosed for ready referenced) and requested for renewal of agreement with the hospital.
5. Sir, we are pained and rather shocked to hear verbal explanation given by the authorities that the Hospital is not giving the business to the BSNL and hence the agreement is terminated.
6. *Sir, nowhere it is mentioned to link the empanelment of hospital with provided business.*
7. A written request signed by THREE MAJOR PENSIONERS ASSOCIATION clearly mentions the reason for renewal of the agreement.

Sir, the issuing being exclusively being ambit of your authority, we urge upon you to kindly have reexamination on the decision of the GMTD Rajkot and cause early renewal of the agreement.
