The Centralised Pension Processing Centre (CPPC), State Bank of India, Bengaluru, organised a Mega Digital Life Certificate Camp at its Administration Office, Bengaluru on 8th November, 2024 to motivate pensioners to submit their life certificates through the Face Authentication Technology

The campaign was inaugurated by Sri V. Srinivas, IAS, Secretary, Department of Pension and Pensioners Welfare, New Delhi. Smt. V. Annie Joyce, Deputy Director General, UIDAI Regional Office, Bengaluru, Sri Sushil Kumar Singh, General Manager SBI, Sri Dhrubatyoti Sengupta, Joint Secretary, DOPPW, Sri Ravikiran Ubale, Director, DOPPW and Smt. Ramanjit Kaur, Senior Consultatnt, DOPPW were present.

Before inauguration of the campaign, Smt. Joohi Smita Sinha, Chief General Manager, SBI Bengaluru Circle, who had earlier expressed her desire to meet some pensioners, met with representatives of Pensioners' Associations present at the venue and interacted with them on pension disbursement related issues involving CPPC SBI. Sri K B Krishna Rao, Secretary, K P&T Pensioers' Association, Smt. Juliana Vincent, Secretary Survey of India Pen Assn, Sri P S Prasad, Secretary Ground Water Board Pen Assn and Sri R. S. N. Murthy, Treasurer, KCGPA participated in the discussion with the CGM SBI.

The DLC Campaign was inaugurated by lighting of the traditional lamp by the dignitaries present on the dais. Smt. V.Annie Joyce, Deputy Director General, UIDAI spoke about the advantages of digitalisation and the contribution of UIDAI Aadhaar database which has facilitated submission of Life Certificate by Pensioners even from the comforts of their homes.

Sri Sushil Kumar Singh, General Manager SBI spoke about the active participation of the SBI in the DLC campaign over the past 3 years.

Sri Dhrubatyoti Sengupta, Joint Secretary, DOPPW, through a power point presentation, explained the process of generating digital life certificate and said that DOPPW, in collaboration with UIDAI & Miety has launched Face Authentication Technology for submission of Digital Life Certificate. He said that Banks and Pensioners' Associations have joined the DOPPW in the DLC campaign and about 1.5 crore pensioners utilised the facility last year.

Sri V.Srinivas, IAS, Secretary, Department of Pension and Pensioners Welfare speaking on the occasion, said that the submission of DLC though initially faced some technical problems, the technology has made tremendous progress over the year, for enhancing "Ease of Living" of 70 lakhs Central Govt. Pensioners who now need not visit their banks or post offices for submission of their annual life certificate for continued drawal of their pension.

Sri K B Krishna Rao, Secretary, KP&TPA gave an account of the Digital Life certificate Camps organised by the Association in Karnataka in association with Coffee Board Pensioners Association and the number of DLCs generated by their volunteers in Camps and during house visits.

S/s Girish Kanagotagi, President KCGPA, R.S.N Murthy, Treasurer KCGPA, and Sri Naganath, Secretary, Karnataka EPF Pensioners Association spoke about some issues concerning pensioners.

LIFE CERTIFICATE: Assisting Pensioners to submit their Annual Life Certificate-2024

In an yet another stellar joint performance by Karnataka P&T Pensioners' Association and Coffee Board Pensioners' Association, Bengaluru, improving upon their last year's joint performance in helping pensioners to register their annual life certificates with the Pension Disbursing Authorities - Banks and Post Offices- for continued payment of their pension, the Pensioners' Associations, both affiliates of CCCGPA, Karnataka, during the month of November 2024, organised 39 Digital Life Certificate Camps - 27 in Bengaluru City in various localities and one each in Mysuru. Thumakuru, Hassan, Shivamoqqa, Chikkamagaluru, Davanagere, Chitradurga, Kolar, Robertsonpet, Tirupathy, Nanjanagudu and Chamarajanagara managed by 33 volunteers who extended their selfless yeomen services to the pensioner community.

The number of volunteers increased from 13 in the year 2022 to 33 in 2024. They were well supported by the Office bearers and members of Residents Welfare Associations, Senior Citizens Forums, Old age homes and of course their friends and acquaintances. The hosts provided the required infrastructure needed for a successful conduct of the camps. The Hospitality extended to the volunteers is noteworthy. It is heartening to record that the Officers of the Department of Posts-the Superintendents and the Head Postmasters extended their helping hand to the associations in holding the DLC camps in the premises of the Head Post Offices

The volunteers visited residences of 1326 aged pensioners, some of whom were bedridden, some using a wheelchair for their mobility, and a few living with oxygen support. They visited some Hospitals and Old age homes also. Their visits to Old age homes to generate life certificates of the inmates received high appreciation from the Managements of

the homes who extended support to the volunteers.

There was a good response from pensioners retired from many Departments of Govt of India, including Defence, Railways, BSNL. EPF. Autonomous Bodies. Banks and State Governments who attended in large numbers In the DLC camps organised by the associations. In the 39 camps held from 3rd Nov to 15 th November 2024, a record number of 2091 pensioners and family pensioners attended the camps. The volunteers generated their digital life certificates by making use of the fast and hassle free "Face Authentication Technology" launched by the Govt of India, Department of Pension and Pensioners Welfare in collaboration with The Unique Identification Authority of India (UIDAI) & Ministry of Electronics and Information Technology (MietY).

Camps in Sahakaranagar, Bengaluru attracted the maximum number of pensioners ie. 257 followed by Camps in Vidyaranyapura, Bengaluru 189, Mysuru 166, Chikkamagaluru 130 and DRDO camp 128. As on 24-11-2024 the total number of Digital Life Certificates generated is a record 3417.

The 2 Associations' endeavour in helping pensioners of all hues to submit their annual life certificate FREE OF CHARGES will continue till 30 th November 2024 and thereafter if requested.

Apart from generating life certificates of hundreds of pensioners in the camps, the volunteers trained a few interested pensioners in downloading the 2 Apps viz. Jeevan pramaan and Aadhaar Face Rd on their mobile phones needed for generating Digital Life Certificates. SOP for DLC registration was also made available to such willing pensioners .We are glad to record that some pensioners in Bengaluru, Shivamogga, Chikkamagaluru and Mysuru have, in right earnest, started helping

pensioners to submit their life certificates from the confines of their homes.

We are deeply indebted to the volunteers who, during the month of October 2024, to provide doorstep service, visited homes of pensioners aged 80 + and in November 2024 homes of infirm pensioners and assisted them to register their life certificates from the confines of their homes. The volunteers travelled far and wide spending their own money, did not mind the stress and strain involved either in travelling to far off places or commuting to many wards of the City. Some days they were on the job throughout the day. Generating more that 3400 life certificates would not have been possible but for their strenuous efforts. It was. undoubtedly, a real team effort in which each and every one of the volunteers contributed his might to the success of the Associations' strivings for helping the pensioners in general and specially those who are old and infirm.

Grant of Notional increment for calculation of pension to those Pensioners who had retired on 30th June / 31st December after serving for one year from the date of drawal of their last increment.

Department of Posts issues a corrigendum to its letter dated 18-10-2024

We are glad that the Department of Posts has issued a corrigendum to its order dated 18th October 24 on grant of Increment to Pensioners who had retired on 30th June or 31st December.

We had, while publishing the order dated 18.10.24 in October 24 issue of our journal *Pensioners' Champion*, informed our readers that the order of DO Posts needed a clarification as it had stated that only those employees who have retired after 30.4.2023 are eligible for grant of increment for pension which was not in consonance with the instructions issued by Dept. of Personnel and Training vide its OM dated14-10-2024.

With the corrigendum dated 11.11.24, the benefit of increment must now be extended to Pre - 30.4.2023 retirees also as envisaged in Department of Personnel and Training OM dated 14.10.2024.

We hope that all the Pension Sanctioning Authorities would suo moto initiate action in this regard.

Department of Posts corrigendum is reproduced below

CORRIGENDUM

Grant of notional increment on 1st July/ 1st December respectively to the employees who retired from Central Government Service on 30th June/ 31st December respectively for the purpose of calculating their Pensionary benefits.

In partial modification, sub para(i) of para 3 of this office OM No.02-14/2020-PAP(Part file) dated 18.10.2024 is s hereby revised as under:-

To allow notional increment on 1st July/ 1st January, as the case may be, to the officials retiring/have retired on 30th June/ 31st December and have rendered the requisite qualifying service as on the date of their superannuation with satisfactory work and good conduct for calculating the pension admissible to them. The benefit of enhanced pension would be admissible w.e.f.1.5.2023 onwards. Enhanced pension for the period prior to 30.04.2023 will not be paid. The notional increment will not be admissible for any other pensionary benefit. The payment of enhanced pension would be subject to the outcome of the above referred Review Petition of the Government of India.

2. All other particulars of the aforesaid OM dated 18.10.2024 remain unchanged.

Note on Restoration of Commutation after 12 years instead of the existing 15 years

Further deduction of commutation amounts from pension has only been STAYED by CAT/ Courts in respect of those pensioners who have filed cases before CAT/ High Court etc. The cases filed before the CAT/ Courts are yet to be considered on their merit and orders passed by the respective Courts/ CATs The interim orders passed by various courts are at variance, in as much as, the period of deduction mentioned varies from 124 months to 132 months. In CAT Mumbai order dated 11.11.2024 in respect of Postal Pensioners,

the period is 120 months, in Punjab and Haryana High court order the period is 128 months and in an yet another order by CAT Chennai it is 132 months. We have to wait for the final outcome of the cases pending before courts and especially till such a time a General Order is issued by the nodal department viz. Department of Pension and Pensioners Welfare, reducing the period of deduction of the commutation amount from pension from the existing 15 years. We have to wait for disposal of the cases pending before courts and issuance of a general order by DOPPW.
