1. Enclosed please find herewith copy of our letter No: BPS/BDPA(I)/Wockhardt Hospital/2024 dated 11.12.2024, wherein we have requested to continue empanelment of N.M. VIRANI, WOCKHARDT HOSPITAL, RAJKOT.
2. Sir, since this Hospital is convenient for the staff members and pensioners of the Rajkot Telecom District, we request your good self to kindly cause continuance of the empanelment of the said hospital.
3. On one side, honoring the requests of the Employees and Pensioners, the corporate office writing to empanel more and more hospitals for CGHS/ECHS, whereas here the available facility is blatantly discontinued by the GMTD Rajkot.
4. Our District Representatives had a meeting with the GMTD Rajkot on 03.12.2024 with written request dated 02.12.2024) and requested for renewal of agreement with the hospital.

5. Sir, we are pained and rather shocked to hear verbal explanation given by the authorities that the Hospital is not giving the business to the BSNL and hence the agreement is terminated.
6. *Sir, nowhere it is mentioned to link the empanelment of hospital with provided business.*
7. A written joint representation signed by THREE MAJOR PENSIONERS ASSOCIATION clearly request for renewal of the agreement.

Sir, the issuing being exclusively being ambit of your authority, we urge upon you to kindly have reexamination on the decision of the GMTD Rajkot and cause early renewal of the agreement.
