He also spoke on latest order on BSNL Pensioners Medical Card Renewal process on line. He said that our demand of directly paying CGHS Subscription by BSNL to CGHS authorities is pending and it is being pursued. He said that comparing to other districts and state, response from Ahmedabad District for Donation needs more supports from the pensioners.

On the district issue of Medical Payment, he said that all concerned have to represent and simultaneously it has to be followed with by the District Level first. On the issue of non-receipt of magazine, he said that it is all India Issue. He said that this year, orders have been issued for on line revalidation of Medical Identity Cards and CGM is requested to nominate the officer in time. Payment of Fixed Medical Allowance is made at quarterly as per BSNL fiscal position and it is being pursued with the Corporate Office.

Nearly 475 members and invited guests witnessed the proceeding. Each delegate was given a BDPA Directory-2025 and a GIFT (Steel Water Bottle).
