Sub: A request to implement BSNL Corporate Office Letter addressed to all the CGMs vide No: BSNLCO-CA/25/4/2021-CA-ERP-FICO/ dated 30.08.2022 on creating Vendor and send information to Corporate Office for payment of Fixed Medical/Indoor/Outdoor payments to BSNL Retired employees.

Respected Sir,

- 1. Sir, we enclose BSNL Corporate Office letter No: BSNLCO-CA/25/4/2021-CA-ERP-FICO/dated 30.08.2022 on the subject.(copy enclosed).
- 2. It reads as under:
 - "This has reference to the above mentioned subject. In this connection, it is intimated that:
 - 1. The Corporate CBB section has allotted funds to the Circles for making payment of medical bills upto 31.03.2022 to retired employees. The Medical bills to working employees as well as CGHS reimbursement to retired employees are already been paid every month together with salary.
 - 2. Going forward, the Circles should post the parked Medical bills of retired employees and deduct TDS, as applicable and these will be disbursed along with the salary of working employees on monthly basis.
 - 3. From September on wards, the Circles should regularly post/create the liability of Medical bills of retired employees in ERP-SAP through defined procedure and deposit the TDS deducted regularly.
 - 4. Effective 1st September, all retired employee vendor payments will be made by Corporate CSC i.e. House Bank/Account Id of Corporate CSC Bank will get updated in liability documents. Therefore the Circles must ensure that Bank Particulars of retired employee vendors are accurately captured in the system; credit to incorrect account shall be the responsibility of circles. Once the payment is made, the Circle should ensure that no old bill/liability prior to 31.03.2022 should appear in the retired employee vendor account group."

Sir, whenever, concerned BSNL Retired Employees contacts his parent office of GM/PGM or CGM Office, it is said that fund is not available and it will be paid on receipt of Funds from Corporate Office.

This clearly proves that your office is either unaware of the said letter or has not implemented the said letter.

We, therefore, request you to kindly circulate the said letter to all GMs/PGMs and to take necessary action as per directive of the Corporate Office and forward all the duly checked indoor/outdoor of BSNL Retired Employees of Gujarat Circle to Corporate Office and also to ensure that vendors are created and informed to competent authorities.

Similar action may kindly be taken to cause payment of fixed-medical allowance for the year 2024-25 at the earliest as the payments are cleared in other Circles.

A line in reply shall highly be appreciated.
