Sub: <u>A request to expedite settlement of long pending Indoor/outdoor and fixed Medical</u> <u>allowance payment to the BSNL Retirees of Haryana Circle – Karnal SSA</u>.

Sir,

1. The Bharat Pensioners' Samaj (BPS), the largest national federation representing pensioners, take this opportunity to bring to your kind notice of esteemed honour to critical issues of settlement of long pending Indoor/outdoor and fixed Medical allowance payment to the BSNL Retirees of Haryana Circle; which is affecting the wellbeing of BSNL pensioners across Haryana Circle; who were backbone of administrative machinery during their service period, are now facing significant challenges in healthcare and financial security deserving sympatric considerations to their woes by your august office.

2. The Circle Secretary, Haryana Circle, has brought to your kind notice the following pending issues relating to approval and payment of long pending cases of BSNL Retirees.

- A. Shri Raj Kishan, SSS (Retd) HRMS HRMS.R- 80088034 for indoor treatment from 29.7.2019 to 06.8.2019.
- B. Shri Rameshwar Chand, Sr.TOA (Retd), HR No. HR.197802580 for indoor treatment for the period from 08/02.2022 to 15.02.2022 – SSA File No: F. No. HR-KRL-26/15(25)/45/2023-F and A KRL BA/41 Dt.17.4.2025.
- C. Case of Smt. Pushpa Rani O.S. (Retd) three claims pending in file F.No.A/इंडोर मेडिकल/1 Smt.Pushpa Rani Retd O/S/07/31.1.

The Circle Secretary, has informed us that "श्रीमान जी उपरोक्त 3 पेंशनर्स के 5 बिल बहुत लंबित हैं,श्री सन्नी कुमार जी JAO (Pay) लेखा विभाग <mark>o/o महाप्रबंधक करनाल द्वारा सभी औपचारिकतायें</mark> पूर्ण करके फाइनल अप्रूवल के लिए आपके कार्यालय में भेज दिए गए हैं! दिनांक 19.3.2025 को माननीय श्री विनोद कुमार जी A.D (MRS) अम्बाला के कार्यालय में श्री चौरसिया जी एंव श्री विक्रम दीप जी (फाइनेंस विभाग) को साथ लेकर मीटिंग की थी उपरोक्त मेडिकल बिलों के सन्दर्भ में विस्तार से चर्चा हुई और A.D (MRS) साहब ने आश्वाशन दिया था कि sr.No.2 श्री रामेश्वर चंद जी करनाल के बिल की रिपोर्ट आनी शेष है उसके आने पर शीघ्र ही फाइनल अप्रूवल करा ली जाएगी! अब रिपोर्ट भी आ गई है."

Sir, in this connection, we enclose BSNL Corporate Office letter No: BSNLCO-CA/25/4/2021-CA-ERP-FICO/ dated 30.08.2022 (copy enclosed) which reads as under:

"This has reference to the above mentioned subject. In this connection, it is intimated that:

1. The Corporate CBB section has allotted funds to the Circles for making payment of medical bills upto 31.03.2022 to retired employees. The Medical bills to working employees as well as CGHS reimbursement to retired employees are already been paid every month together with salary.

2. Going forward, the Circles should post the parked Medical bills of retired employees and deduct TDS, as applicable and these will be disbursed along with the salary of working employees on monthly basis.

3. From September on wards, <u>the Circles should regularly post/create the liability of</u> <u>Medical bills of retired employees in ERP-SAP through defined proced</u>ure and deposit the TDS deducted regularly.

4. Effective 1_{st} September, all retired employee vendor payments will be made by <u>Corporate CSC</u> i.e. House Bank/Account Id of Corporate CSC Bank will get updated in liability documents. Therefore the Circles must ensure that Bank Particulars of retired employee vendors are accurately captured in the system; credit to incorrect account shall be the responsibility of circles. Once the payment is made, the Circle should ensure that no old bill/liability prior to 31.03.2022 should appear in the retired employee vendor account group."

Sir, in light of above, you are requested to post/create the liability of Medical bills of retired employees in ERP-SAP through defined procedure.
