**Subject: Response to Letter No. BPS/BDPA (I)/Haryana/2025 dated 16th June, 2025 regarding Pending Pension Cases issues - Haryana Circle**

Sir,

With reference to your letter under reference, the issues raised concerning pension matters of BSNL retirees under Haryana Circle have been examined in detail. The point-wise status is provided below for your kind information:

**1-4: Cases related to FMA, Restoration, and Family Pension (As per PDA Section)**

**1. Sh. Mam Chand - FMA Issue:**

The FMA could not be regulated due to technical reasons. Arrears from **March to May 2025** were approved and has been released through the **Supplementary Bill on 20th June 2025**.

**2. PPO No. 132014111204311 - Smt. Santosh (F.P.):**

The **due pension has already been paid on 30.05.2025** via the Supplementary Bill.

**3. PPO No. 132010101201538 - Smt. Phoolwati (F.P.):**

The **arrears were disbursed on 06.06.2025** via the Supplementary Bill.

**4. PPO No. 132020012201799 - Smt. Anupama (W/o Late Sh. Surender Mohan):**

The **family pension case has been settled**, arrears up to May 2025 were approved, and the same has been released through the **Supplementary Bill on 20th June 2025**.

**5. Notional Increment Cases (As per Pension Section)**

- As per DoPT OM dated 20.05.2025 and DOT OM dated 26.05.2025, the judgement will be given effect to in case of third parties from 01.05.2023. Hence the enhanced pension will be given effect from 01.05.2023 after adding one notional increment for which the revised form-7 and calculation sheet along with certificate that "employee has completed one year of qualifying service as on the date of his superannuation with satisfactory work and good conduct" are required. All four cases have been forwarded to the respective BSNL authorities for resubmission. However, **complete case files have not been received** in this office till date. The details are as follows:
