## **NON-PAYMENT OF PENSION SINCE LAST ONE YEAR**

**Sub: Non-payment Pension, Leave Encashment, G.P.F. & Gratuity since last one year – Case of Shri Ramjee Sah, ATT (HRMS No. 199412014) – Retired from the o/o the GMTD BSNL, Ranchi Jharkhand on 31.05.2024.**

Most Respected Sir,

1. We write invite your kind attention towards the utter negligence shown by the office of the CGMT Jharkhand Circle and the CCA Ranchi; resulting in suffering of the poor BSNL Retiree who is suffering from T.B.
2. Before providing details of the case, we would like to enclose a copy of representation dated 27.06.2025, addressed to the Secretary (PG), DOPPW, New Delhi, which speaks of the injustice meted out to the poor pensioner.
3. Shri Ramjee Sah, ATT (HRMS No. 199412014), was retired on superannuation from the office of the GMTD BSNL Ranchi on 31.05.2024. The official was recruited as Regular Mazdoor on 13.05.2194 in DoT period.
4. We enclose herewith copy of Relieving Order BiLSDE Dhruwa/Misc/2024-25/6 dated 31.05.2024 issued by the office of the GMTD Ranchi. (Enclosure-1)
5. **It was the duty of the PGM BSNL Ranchi to prepare the case of the Pensioner** before six months of retirement but it appears that HE **DID NOT**.
6. The CCA Ranchi should have been informed by the PGM Ranchi to sanction provisional pension, in absence of Presidential Order.
7. The Pensioner had already applied for issuance of Presidential Order vide his option form dated 02.09.2008 received by the D.E. Admn. (Copy enclosed).
8. As the same was not received, the Pensioner has on his retirement requested for issuance of Presidential Order vide his representation dated 10.07.2024 (copy enclosed).
9. The AGM Ranchi Business Area vide his letter No: **व्य-3657/रामजी साह/आरएम/52** dated 11.04.2025 has issued a reminder to the PGM Ranchi which reads as Under:

श्री रामजी साह, सेवानिवृत्त एटीटी, राँची (एचआर संख्या- 199412014) ने पुनः आवेदन देकर प्रोविजनल पेंशन भुगतान करने का अनुरोध किये हैं। आवेदन अनुसार श्री रामजी साह की आर्थिक स्थिति दयनीय हो गई है और ये टी. बी. रोग से पीड़ित हो गए हैं।

विदित हो कि श्री रामजी साह दिनांक 31.05.2024 सेवानिवृत्त हुए थे इनकी नियुक्ति DOT के समय 13.05.1994 को हुई थी जिससे ये पेंशन सुविधा पाने के हकदार हैं परन्तु इनका राष्ट्रपति आदेश (Presidential Order) जारी नहीं हुआ जिसके कारण इनके सेवानिवृत्ति के पश्चात् किसी प्रकार का सेवानिवृत्ति लाभ का भुगतान इनको नहीं हुआ।

अतः आपसे अनुरोध है कि उपरोक्त तथ्यों को ध्यान में रखते हुए इनको प्रोविजनल पेंशन भुगतान करने सम्बन्धी दिशा निर्देश देने की कृपा करें।

**Sir, the letter clearly says that the official is entitled to get Pensionary benefit but for non receipt of Presidential Order, even after retirement the official could not be given any retirement benefit.**

**Now our submission is as under**

*This is utter negligence on the part of the office of the PGM BSNL Ranchi as well as the office of the CCA Ranchi in not extending the benefit of Provisional Pension for which the orders are also clear and the office of the CGCA New Delhi is time and again reiterating to issue provisional pension in such cases. The Pensioner is suffering from TB for which has also provided his treatment card.*

We therefore request you to kindly cause issuance of instructions to the CCA Ranchi to sanction provisional pension and releasing the GPF for which the presidential order has no relativity. The office of the PGM Ranchi may also be advised to release the Leave Encashment on the basis of the salary he was drawn by the BSNL Authorities.
