1. We enclose herewith a copy of your letter No: :GJCO-27/12(12)1/2021-GJFIN-CSC Dated 03.07.2025 wherein it has been desired that **BA Office should ensure that claims and reimbursement should not be kept on hold or delayed without any sufficient reason.**
2. We would like to bring to your kind notice that the said letter is issued with good spirit and need of hour. But we regret that the said letter is made applicable only to working employees; **whereas it has indirectly given free hand to BA Offices to ignore such claims of BSNL Pensioners.**
3. We therefore request to reiterate similar instructions for BSNL Pensioners as well.
4. We regret to inform you that in our visit to Valsad, Surat & Vadodara districts on 11<sup>th</sup> & 12<sup>th</sup> August, 2025 with our All India President Thomas John K, **it was bitterly complained by all the units Surat & Vadodara have not effected the payments of fixed medical & reimbursement of BSNL Pensioners for the Business area under them since last four years.**

We therefore request to issue similar letter for BSNL Pensioners and also to instruct them to clear pending payments of BSNL Pensioners.
