# Minutes of the Annual General Body Meeting of the Co-ordination Committee of Central Government Pensioners' Associations, Karnataka, held on 02-08-2025 at 10:30 am in Udayabhanu Kala Sangha, Gavipuram, Bengaluru - 560 019

The Annual General Body Meeting of the Co-ordination Committee of Central Government Pensioners' Associations, Karnataka, was held on 2nd August 2025 in Udayabhanu Kala Sangha, Gavipuram, Bangalore – 560 019.

#### Chief Guest Sri D. Balasubramanian, General Secretary, All India Federation of Pensioners' Associations, Chennai

About 80 representatives from various Affiliate Pensioners' Associations were present. The meeting commenced at 10:30 AM under the Presidentship of Sri K.B. Krishna Rao.

Sri Radhakrishna, General Secretary (GS) warmly welcomed President Sri K B Krishna Rao, to the dais and also all the Affiliates and participants present. The GS then read the notice of the AGM issued on 2-07-2025 and following agenda as published in the notice was adopted by the house.

- Health care-CGHS, Non-CGHS areas and Pensioners of Autonomous & Statutory bodies.
- Functioning of Advisory Committees at WCs CGHS and Zonal Advisory Committee.
- Notional increment for those who retired after completing 12 months after earning the previous increment.
- Election of office bearers for the year 2025-26 and 2026-27.
- 10. Nomination of Auditor for the years 2025-26 and 2026-27.

As the Chief Guest had not yet arrived the inaugural session was deferred and other items of agenda were taken up for discussion

Condolences: General Secretary placing the condolence resolution mentioned that following leaders and dignitaries expired during the period from last AGB to date. V.S. Achyuthanandan, former Chief Minister Kerala, SC Maheshwari, Secretary General, Bharath Pensioners Samaj, S.S. Ramanatha Rao, former Vice Chairman of CCCGPA and former President of KCGPA, A.N. Balaram, former President Coffee Board Pensioners Association. He also stated that the innocent tourist died in Pahalgam in Kashmir due to terrorist attack and 230 passengers who were killed in the Boeing 787 plane crash at Ahmedabad. He

also expressed heartfelt condolences to all the departed members of the affiliated organizations during the year.

The house observed a minute's silence to pay homage to the departed.

## 2. Confirmation of Minutes of the Annual General Body Meeting held on 10 August 2024

The General Secretary informed that the Minutes of the AGB held on the 10 August 2024 had already been circulated to all the affiliates and also published in the journals published by the affiliates. No amendments to minutes have been received. If house approves, minutes can be taken as approved. The House unanimously approved the Minutes.

### 3. Annual Report and Audited Statement of Accounts for the year 2024-25

General Secretary placing the annual report highlighted about certain important subjects mentioned in the report. Mentioning about "Validation of the CCS(Pension) Rules and Principles for Expenditure on Pension Liabilities" which was passed by the Parliament on 29/3/2025 as part of the Finance Act 2025, he stated that through this amendment the Government has annulled the spirit of Judgement by a Constitution Bench of the Supreme Court passed on 17/8/1982 popularly known as Nakara Judgment & hailed as the "Magna Carta" of pensioners.

He explained in detail what led to the Nakara case and its impact on the recommendations of fourth, fifth, sixth and seventh Pay Commissions. However, whatever was achieved through the Nakra Judgement has now been taken away because of the validation clause which has given powers to the Government to categorise pensioners as per the date of their retirement. Though in the virtual meeting held by the Secretary DOP&PW, attended by the representatives of many Pensioners' Associations, the Secretary DOP&PW assured that the validation of Pension Rules would not have adverse effect on the

pension of the existing pensioners, he did not clarify the issue in writing as promised by him in the meeting.

Hence the Pensioners Associations had a detailed discussion and chalked out a plan of action in this regard to bring pressure on the Government to withdraw the validation clauses. The NCCPA gave a call for holding Demonstrations all over the country on 3.4.2025. In Karnataka, Bangalore, due to non-availability of a venue on 3.4.2025, the CCCGPA, Karnataka, conducted the demonstrations on 4/4/2025 at Freedom Park. The affiliate associations of CCCGPA Karnataka and other Pensioners' Associations participated, which was attended by about 500 pensioners.

He further stated that a Forum of Civil Pensioners' Assns (FCPA) was formed under the NCCPA leadership and it was decided to file a Writ Petition in the Supreme Court alongside agitation programmes to oppose the validation of pension rules. A call was also given to the associations to raise donations and a legal fund was created by NCCPA- CHQ. Appeal for liberal donations from pensioners was made to help meet the Supreme Court expenses. Further, All-India programmes were chalked out - one, being a "human chain" by pensioners in various districts on 25.7.2025 and a convention and submission of memorandum to the Governor between August 24th and 28th and a pensioners rally on October 10th at New Delhi.

Karnataka units of Pensioners Associations in the Forum of Civil Pensioners Associations in a virtual meeting held on 19.7.2025, decided to implement all the programmes given by the Forum under the banner of CCCGPA. Considering the restrictions on holding the rallies on the roads in Bangalore, a human chain programme was conducted on 25.7.2025 within the premises of the old CTO building, Rajabhavan Road, Bengaluru. Around 300 pensioners from the affiliates of the Forum participated in the Human Chain programme demanding Withdrawal of the validation of

pension rules, Constitution of 8th CPC and release of the terms of reference and Inclusion of revision of pension of BSNL and autonomous bodies pensioners in the terms of reference of 8th CPC.

As the Chief Guest arrived, it was decided to continue the discussions later and inaugural session was commenced.

#### **Inaugural Session**

President, Com, Krishna Rao, welcomed Chief Guest Com. D. Balasubramanian, General. Secretary, All India Federation of Pensioners' Associations warmly saying that he had been leading Pensioners for decades. He further added that it was for the first time that Com Balasubramanian was addressing the CCCGPA Karnataka, but he had earlier in 2018, was the Guest of Honour in the opening ceremony of Pensioners' Bhavan, the building constructed by Karnataka P&T Pensioners Association in Telecom Layout, Bengaluru, an occasion to cherish. Sri Rao requested Com Radhakrishna to introduce Balasubramanian to the House and formally welcome the Chief Guest.

Com. Radhakrishna, while extending a warm welcome to Com. Balasubramanian, recollected that he had taken over the post of President of All India Audit & Accounts Officers Association (IA&AD) from Com Balasubramanian in the year 2006. He mentioned the activities of Com. Balasubramanian and stated that he was a front line leader of IA&AD employees movement in Chennai and was victimised many times for leading various agitations. He highlighted his present role in the Pensioners' movement in Chennai and at the national level.

He informed Com. Balasubramanian that the CCCGPA Karnataka was formed in the year 1998 under the leadership of Com. N. Bhaskaran as the General Secretary and Com. Sadashiva Rao as Chairman and has 32 affiliate organisations. He further mentioned that CCCGPA is working in close

coordination with state unit of Confederation of CGEs on common issues confronting pensioners and employees.

Com. Radhakrisha assured that the CCCGPA Karnataka will implement all the calls of the Forum of Civil Pensioners' Associations and the NCCPA. Thereafter, Com. Krishna Rao, welcomed all the members to the meeting and requested the Chief Guest to inaugurate the General Body meeting.

### Inauguration by Com. D. Balasubramanian, Gen. Secy., AIFPA, Chennai

In his inaugural address, the Chief Guest Com. D. Balasubramanian mentioned that the All Indian Pensioners' Association of Chennai was 46 years old. He talked about the close connection and interactions between the Pensioners' Association of Chennai and Karnataka. He paid tributes to Com SC Mahaeshwari Secretary General of BPS who expired recently. He shared his opinion that the main problems of older people is that there is no one to take care of them and they face Ioneliness. He said that the Pensioners' Associations take care of the welfare of the elders. In Chennai, they organise meetings once in a month without fail. He thanked Com. Krishna Rao for the opportunity given to attend and inaugurate the GB of CCCGPA.

Speaking of the current issues, he mentioned about the delay in constitution of the 8th Pay Commission though it was announced by the Government on 16.01.2025. While recalling the role of late Com. SK Vyas, in preparing the memorandum for submission to the Pay Commissions and late Com. Kutty carrying out the legacy, he requested Com. Radhakrishna to find time for preparation and submission of a memorandum to the Pay Commission.

He informed that in the Standing Committee of Voluntary Agencies (SCOVA) meeting, the AIFPA had brought up the issue of the validation of pension rules as a part of the Finance Bill and its effect on the pensioners. The Secretary, DOP&PW, had assured that there will not be any effect on the existing pensioners. However, the minutes of that meeting was not given though the same was asked for.

He mentioned the two court cases which are pending disposal. He explained in detail the implications of the effect of the Validation of Pension Rules. He mentioned about the decision that the Pensioners' Association of all states are to send a memorandum to the Govt. of India, through the Governors, requesting withdrawal of the Validation of Pension Rules.

He said that the apprehension is that the benefits of the 8th Pay Commission may not be extended to those who retired before 2025 and hence the decision of the Forum of Civil Pensioners Associations to take legal action for which Shri Kapil Sibal, Senior Advocate was approached.

He said that the human chain agitation programme gave a rousing voice to the demand to withdraw the 2025 Act and mentioned that the vibrating voice was raised throughout the country. He talked about the demand from the Associations side to restore the old pension scheme which was changed to NPS from 2004.

He cautioned the serving employees to not have the illusion that they are safe but to fight for their rights as the position of their pension is scary.

He appreciated Karnataka Posts and Telecommunications Assn in taking the lead in generating the maximum number of Digital Life Certificates for the needy pensioners. He added that the P&T organisations are noted for their bravery and trademark of fighting injustice. Regarding BPS joining the legal action, he said that he would try to convince those who did not see the reality. He concluded that we should learn the lessons of the past and fight for the retired, present and future working together with both State and Central Govt pensioners' against injustice. We should strengthen the Movement and see that the Govts' motives are defeated.

In response to the Chief Guest's address, Com Radhakrishna said that the CCCGPA affiliates also include Kendriya Vidyalaya pensioners association and autonomous bodies pensioners association. EPF pensioners' Association, Akhila Karnataka Akashwani and Doordarshan Pensioners' Assn got newly affiliated to the CCCGPA, Karnataka He thanked Com. Balasubramanian for his inspiring talk.

Com. Krishna Rao also thanked the Chief Guest for his specific mention of the role of KPTPA in generating the Digital Life Certificates.

The house resumed discussion on the Annual Report & Audited Accounts for the year 2024-2025

The Gen. Secretary's report was taken as read and was approved unanimously.

#### 3.1. Annual Accounts

Com. S. Krishnamurthy, Treasurer, presented the accounts statement to the GB and read out the same which was passed unanimously. He mentioned that many of the affiliates had not paid the annual subscription which had caused shortage of funds for the functioning of CCCGPA Karnataka. He requested for individual donations which would also be appreciated.

With regard to the financial position of CCCGPA, Com. Radhakrishna informed that the Suratkal NIT pensioners' Association was dissolved and a portion of the funds remaining with the Association were paid to CCCGPA Karnataka. Hence CCCGPA could manage some expenses. However, we have more expenses at present as more programmes have to be conducted. Though two programmes are over, the next programme of a convention in August and Delhi Chalo in October are to be taken care of. He requested affiliates to pay an extra donation of minimum of Rs. 1000/- as a special fund. He said that only 13 affiliates of 33 associations had paid their subscription and requested the Treasurer to inform each of the associations to pay their dues.

The Accounts were approved by the house unanimously.

#### 4.8th CPC

Com. Radhakrishna mentioned that after the announcement by the Government to constitute 8th CPC, CCCGPA held a MC meeting on 15th March 2025 and finalised the issues to be included in the common memorandum on pensioners' issues to be submitted to the Pay Commission. These issues were also mentioned in National Executive meeting of NCCPA held on 19<sup>th</sup> April 2025 at Delhi. In that meeting Com. Radhakrishna and Suryaprakash participated.

# 5. Proposal to file a writ petition by Forum of Civil Pensioners Associations in the Supreme Court against Validation of the Central Civil Services (Pension) Rules as a part of to Finance Act 2025

Com. Radhakrishna informed that in the virtual meeting of Civil Pensioners Association held on 10<sup>th</sup> June 2025, it was unanimously decided to form "Forum of Civil Pensioners Associations" and challenge the Validation clause in Finance Act 2025 in the Supreme Court. He informed that Com. Raghavendran, SG, NCCPA, convenor of the Forum had assured that the draft of the Writ Petition when ready would be circulated and invite suggestions and Modifications to the petition, if any.

## 6. Health care-CGHS, Non-CGHS areas and Pensioners of Autonomous & Statutory bodies.

Com. Radhakrishna informed that it is learnt that the revision of CGHS package rates were in the final stage of approval and is likely to be announced shortly. All existing empanelled HCOs had to first get de-empanelled and again re-empanelled with fresh MOU and adopt new package rates. For empanelment, the hospitals need to have a minimum of 100 beds. The NABH acredition condition has been relaxed and the hospitals will have 6 months' time to complete the procedure after empanelment.

Com. Radhakrishna appraised the House of the position of Doctors on Record and Doctors posted in various Wellness Centres. He mentioned that interior and renovation work are going on in the building allotted by Huballi-Dharwad Corporation for establishing an extension counter of CGHS WC. He further mentioned that Health Ministry has approved in principle opening of WCs at Shivamogga, Mangaluru and Udupi. The CCCGPA is demanding upgrading of Sahakarnagar and Hubballi WCs extension counter to full-fledged WCs. In addition, CCCGPA is demanding opening of more WCs in Bengaluru. With regard to CGHS functioning, members brought up various points as mentioned below:

- There were referral hospitals in South Bangalore but not many hospitals in East and West Bangalore
- \* Indifference shown to CGHS beneficiaries, mentioning an instance when a pensioner was referred to the Ortho Specialist at Aster Hospital, Hebbal
- Complaints were made regarding doctors arriving late and making the patients to wait for long
- A request was made that CGHS Wellness Centres must be opened on time at 7:30 AM
- Cleaning was poor at a Wellness Centre and issue of tokens were getting closed early
- \* In Wellness Centre No 9, patients had to stand and wait, some days on the road, as there was insufficient space and improper seating arrangements.
- \* At Sahakarnagar Wellness Centre, the accommodation is not properly utilised
- Doctors write prescriptions but there is no one to give medications at sahakaranagar WC
- \* Pharmacists do not know English
- \* One more doctor is required at the Wellness Centre in Mysore. The patients are more in number and the doctor himself is facing stress

- \* EPF pensioners have no CGHS benefit and expressed the problems faced in this regard
- \* There was a proposal to overcome the difficulties faced by beneficiaries due to repeated visits to Wellness Centres for the collection of medicines, by introducing a facility for delivery of medicines to the residence of the patients on a payment basis.

General Secretary assured that all the above issues will be taken up in ZAC meeting and also will be pursued with CGHS authorities at the Directorate.

### 7. Functioning of Advisory Committees at WCs CGHS and Zonal Advisory Committee.

The monthly meetings of the Advisory Committee members with the CMO of the respective Wellness Centres are being held regularly. Most of the issues are addressed in these meetings.

The Zonal Advisory Committee meetings are conducted regularly with the Addl. Director, CGHS, along with hospital representatives and issues which cannot be addressed at the Local Advisory Committee level are addressed in the ZAC meetings.

# 8. Notional increment for those who retired after completing 12 months of service after earning the previous increment.

On the issue of notional increment, Com. Krishna Rao mentioned that the issue has almost been resolved and the orders of the Supreme Court in this regard have been implemented by the Department of GOI by issuance of formal orders

At present, Bhavishya cannot be modified. Before 2018, details of pensioners were uploaded manually. CPAO has been approached and has agreed to amend the software and also provide guidance.

9. Election of office bearers for the year 2025-26 and 2026-27 and Nomination of Auditor for the years 2025-26 and 2026-27.

Com. S. Radhakrishna, Gen. Secretary, informed that Management Committee of CCCGPA consists of ten office bearers and 11 management committee members. Normal practice is affiliated organisations furnish their nominations to the MC and after discussion a panel of office bearers and MC members placed before the house for consideration. If house permits he will place the panel for consideration. The house unanimously agreed. Afterwords, he placed the following panel before the house.

Many association representatives came forward and paid special donations to CCCGPA Karnataka which was taken on record by the Treasurer immediately. The GS appealed to all the affiliate to make a special contribution of minimum of Rs.1000/-

# Validation of CCS Pension Rules Programmes of Agitations & Filing of Writ Petition in the Hon'ble Supreme Court by the Forum of Civil Pensioners Associations

#### **UPDATE**

Protest against Validation of the Central Civil Services (Pension) Rules 1972 & 2021 and Central Civil Services (Extraordinary Pension) Rules 2023 passed in Lok Sabha as part of Finance Bill on 25,03,2025.

In response to the call given by the National Coordination Committee of Pensioners Associations (NCCPA-CHQ) and the Forum of Civil Pensioners Association of 78 Pensioners Associations across the Country, KP&TPA participated in all the agitations conducted under the banner of the Coordination Committee of Central Government Pensioners Associations Karnataka (CCCGPA-K) protesting against the legislation regarding "Validation of Pension Rules" and "principles of expenditure on pension liabilities" passed in the Parliament as part of the Finance Bill 2025.

The first programme was the Demonstration held at FREEDOM PARK Sheshadri Road, Gandhinagar, Bengaluru on 4.4.2025 participated by 15 Pensioners Associations and about 500 pensioners (Report with photos published in pages 5&6 of the journal- April 25 issue)

The 2<sup>nd</sup> protest programme was "Human Chain" held on 25-07-2025 in CTO Compound, Rajabhavan Road, Bengaluru. Many Associations including non-affiliates of CCCGPA-K and a huge number of pensioners participated in this protest also. The protest was held in other cities of the State Viz. Mysuru, Hubballi, Shivamogga, Davanagere, Ranebennur, Raichur, Belagavi, Chikkamagaluru, Tumakuru, Mangaluru (Some photos posted below)

The next programme of action is of holding State Level conventions of Pensioners

Associations between 24-8-2025 & 28-8-2025 and submission of a Memorandum to the Hon'ble Governor with a request to forward the same to the Hon'ble Prime Minister.

A common memorandum drafted by the SG, NCCPA in consultation with the members of the Civil Pensioners Associations Forum, will be submitted by the associations across the country to the respective Governors of the states.

The convention in Bengaluru is being held on 31-08-2025 at the Telephone House, Rajbhavan Road, Bengaluru. Sri D Gopalakrishnan, President, All India BSNL Pensioners Welfare Association, the Chief Guest will speak about the "Validation Rules" and the need for filing a writ petition in the Hon'ble Supreme Court challenging the bill passed by the Parliament .

The 3<sup>rd</sup> phase of the programme is to meet the members of Parliament by the representatives of the Forum to seek their support in resolution of the demands of pensioners.

And the protest will culminate with the programme "Delhi Chalo" and a Dharna in Delhi on 10-10-2025. A huge number of pensioners from all the states of the nation are expected to participate. A memorandum will be submitted to the Hon'ble Prime Minister after the Dharna

- 1.Visit the official CGHS portal at cghs.mohfw.gov.in
- 2. Navigate to' Apply for CGHS Card available at the top of the homepage and follow the on-screen instructions to complete the online application.
- 3. After submission, the application and uploaded documents (should be cleared) will be verified (the uploaded documents should be clear, detailed and viewable)
  - \* If any discrepancies are found, the application will be rejected at the DA (Dealing Assistant) module level.
  - \* The status of the application can be checked by visiting the "Apply for CGHS Card" section on the portal and by login with your registered mobile number.
- 4. Once your application is approved, a payment

link will be generated and you will also receive an SMS notification. This link will be available when you login again under the "Apply for CGHS card" section.

**Note:** In case you didn't receive any SMS for payment or rejection of application, please check your status by revisiting the "Apply for CGHS card" section on the portal and login with your registered mobile phone number.

5. After making payment through the link,the CGHS card can be downloaded directly from the portal.

#### **IMPORTANT NOTE:**

Do not make payment separately through the Bharat Kosh portal before applying for the CGHS card,as it will not be considered valid for issuance of CGHS card.
