Sir,

1. We enclose herewith copy of representation dated 15.09.2025, submitted to your office through Professional Couriers vide No: 2089145 Dated 17.09.2025, followed with reminder dated 10.11.2025 requesting your office to correct his surname BARIA which is erroneously written as Bariya by your office in the PPO of the Pensioners; which has resulted into denying the issuance of Medical Identity Card by the office of the PGMTD Vadodara.
2. The Pensioner retired on 30.06.2025 and all the documents were correctly submitted by the office of the PGMTD Vadodara and the Pensioner himself, where in the surname is clearly spelt as 'BARIA' whereas while issuing PPO No. **38202561211646** your office has erred and written as "BARIYA"
3. The pensioner has submitted number of documents authenticating his surname as "BARIA" which could have been seen by your office. We fail to understand the reason for not entertaining the representation of the Pensioner depriving the pensioner from procuring his medical identity card and other departmental facilities.

4. Since the documents submitted by pensioners are more, we send copies of the documents with a request to correct the surname of the Pensioner in his PPO and also to issue necessary corrections in all his records for pension in your office.
