The Forum of Civil Pensioners Association in coordination with NCCPA, as the last phase of the present agitations against the Validation of Pension Rules, organised “Delhi Chalo” agitation on 10-10-2025 and held a demonstration at Janthar Manthar in New Delhi. A large number of Pensioners from different parts of the country participated

Comrade K.Ragavendran, SG NCCPA in his a brief speech spoke about the "validation of Pension Rules" passed by the Parliament with the Finance Act 2025 which has lead to a series of agitations being organised by the Forum of Civil Pensioners Associations which has culminated in the Delhi Chalo Demonstration. Honourable Member of Parliament Sri.Ujjaval Raman Singh from Allahabad constituency; Sri.Tapen Sen former M.P and GS of CITU; Ms.Amarjeet Kaur, GS, AITUC; Com. Animesh Mitra GS BSNLEU; comrade

S.S.Mahadevaiah GS, AIGDSU addressed the gathering. Memorandums were given to Honourable President and Prime Minister after Dharna. - KR SG NCCPA

Com Juliana Vincent, Joint General Secretary, CCCGPA Karnataka who is also the Secretary of Survey of India Pensioners Association, represented Karnataka in the Dharana and also signed the Memorandum presented to the President & Prime Minister

The Chief Executives of the Constituent Associations of the Forum Shri. G. L. Jogi, G/S SNPWA and other leaders of the Forum addressed the huge gathering. From MREWA, Sri. R. K. Mudgal, G/S MREWA also addressed the gathering. In his address, he focused on the ill conceived Amendment made to CCS Pension Rules, 1972 (Now 2021) in the form of Validation Act, a part of Finance Bill -2025 with retrospective effect ie. wef 01.06.1972.



DEARNESS RELIEF FROM 1-7-2025

Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare OM No. 42/02/2024-P&PW(D) Dated 08th October, 2025

Release of an additional instalment of Dearness Relief (DR) to Central Govt. Pensioners/Family Pensioners revised rate with effective from 01.07.2025

The undersigned is directed to refer to this Department's OM No. 42/02/2024-P&PVW(D) dated 11.04.2025 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/Family Pensioners shall be enhanced from the existing rate of **55% to 58%** of the basic pension/family pension (including additional pension/family pension) **w.e.f. 01st July, 2025.**

2. These rates of DR will be applicable to the following categories:-

- (i) Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D) Vol. II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
- (ii) The Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates.
- (iii) All India Service Pensioners/Family Pensioners.
- (iv) Railway Pensioners/Family Pensioners.
- (v) Pensioners who are in receipt of provisional pension
- (vi) The Burma Civilian Pensioners/Family Pensioners and Pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PVV(B) dated 11.09.2017.

3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

4. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS (Pension) Rules, 2021 and this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.

5. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.

6. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.

7. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness Relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528- TA, 11/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.

8. In so far as the persons serving in Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India,

as mandated under Article 148(5) of the Constitution of India.

9. This issues in accordance with the Ministry of Finance, Department of Expenditure's OM

No. 1/4(i)/2025-E.1I(B) dated 06.10.2025.

An Update

The Writ Petition of 369 pages challenging the constitutional validity of "validation of Pension Rules" was filed in the Hon'ble Supreme Court on 15-10-2025.

18 Pensioners Associations in the country, including Karnataka Posts and Telecommunications Pensioners Association are the petitioners.

The petition is filed under Article 32 of the Constitution by the Advocate Sri Mudit Gupta for the Petitioners. It is hoped that the WP(C) will be admitted by the Hon'ble Supreme Court and the prayer of the petitioners for declaring the "validation of CCS (Pension) Rules introduced in Part IV of the Finance Act 2025, as Ultra Vires and unconstitutional is granted.

Advisory to CGHS Beneficiaries Migration to TMS 2.0 and implementation of Revised CGHS Rates (effective 00:00 hrs, 13.10.2025)- Instructions to Pensioner beneficiaries who are eligible for Credit.

Reference: CGHS Office Memoranda on (i) on-boarding to NHA IT platforms dated 19.08.2025 and (ii) Revised CGHS Rates issued vide O.M. dated 03.10.2025.

The Central Government Health Scheme (CGHS) is migrating to the NHA platforms (TMS 2.0/UMP/HEM 2.0) and implementing **Revised CGHS Rates** with effect from **00:00 hrs (midnight) of 13.10.2025**. To ensure a smooth, safe, and transparent experience, all CGHS Pensioner beneficiaries who are eligible for credit to follow the instructions below.

A. Access to Care & Identification

- i. **Care will not be denied due to referral issue date.** All empanelled Health-Care Organisations (HCOs) have been instructed to provide treatment to eligible CGHS beneficiaries even for valid referrals issued before 13/10/2025.
- ii. **Use of Digital CGHS Card is valid.** If physical CGHS card (Both plastic and paper cards are acceptable, provided the card's validity is clearly indicated.) is not available beneficiary may share a downloaded e-card from CGHS website (cghs.mohfw.gov.in), My CGHS 2.0 mobile app, or Digi Locker .A clear soft copy is acceptable at HCOs.

B. Mobile Number, OTP Verification & Consent

- i. **OTP verification on beneficiary's registered mobile number is mandatory** in TMS 2.0 for claim submission. Accordingly, beneficiaries are requested to share the same with the HCO upon request.

* Please ensure mobile number is updated in the CGHS database. If beneficiary's number is missing on the TMS 2.0 portal, beneficiary will be requested to provide the correct contact number so the HCO can proceed with registration. To update mobile number, contact the nearest CGHS Wellness Centre (WC).

* If an error occurs on the TMS portal because of missing beneficiary's photograph/ward entitlement, beneficiary may contact the Office of concerned Additional Director (AD) City where the card is registered and have the photo uploaded and ward entitlement updated

Sample OTP SMS (for awareness):

"Dear User, use OTP 507978 to proceed with verification, if you have understood the Aadhaar consent. Note: this OTP is set to expire in 10 minutes. NHA"

Under **exceptional circumstances**, the attendant's mobile number may be used for OTP verification. HCOs will record this in the TMS 2.0 portal along with the relation of the attendant.

C. Geotagging, Feedback & Transparency

Geotagged photo: HCOs have been issued guidelines for **geotagging at the point of care**. Beneficiaries are requested to co-operate when the HCO captures a geotagged photograph.

Mandatory feedback at discharge: As part of quality monitoring, please fill the **CGHS feedback form** at discharge. This form will be uploaded by the HCO with the claim. **Beneficiary/Patient's Attendant must clearly state if any amount was collected during admission. (Annexure 1)**

D. Billing Rules Beneficiaries Must Know

Revised vs Old Rates (date-wise):

- Services **on/after 13.10.2025 (00:00 hrs)'** **Revised CGHS Rates** apply.
- Services **up to 12.10.2025 (23:59 hrs) '** **Old CGHS Rates** apply.

Separate bill for inadmissible items:

If the HCO charges the beneficiary for **inadmissible items** (items not payable under CGHS rules), the HCO must issue a separate bill/receipt. (**Annexure 2**)

- Such inadmissible items **must not be included** in the final bill to be claimed from CGHS.
- No draft/temporary/running bills** are acceptable. The HCO will **upload a copy** of any such separate inadmissible-items bill with the claim.
- Beneficiary should collect and retain proper bills/receipts** for any payments made.

E. Grievance Redressal & Misuse Prevention

- Hospital-level grievance desk:** Every empanelled HCO is required to maintain a grievance redressal mechanism. If needed, please approach the **Nodal officer** at the HCO (details to be displayed at the facility).

- Report any suspicious intimation:** If any beneficiary receives an **SMS/any intimation** for a service which was **not availed from HCO**, inform office of the **respective AD City where card is registered immediately** for verification and action.

Any misuse of the CGHS card—by a beneficiary or an empanelled HCO—constitutes an offence and will attract action under applicable rules and law.

These measures protect beneficiaries, improve service quality, and prevent misuse of the CGHS scheme.

This advisory takes effect immediately and shall remain in force along with the referenced Office Memoranda till further orders.

Delay in Payment of Arrears of Dearness Relief (DR) for 3 Months July to September 2025

We were given to understand that the HPOs were waiting for an endorsement of Department of Pension and Pensioners Welfare OM dated 8-10-2025 on enhancement of DR from 55 to 58% from 1.7.2025 from DO Posts.

Most unfortunately, the Department of Posts did not upload the DR order dated 8.10.25 on its website even by 16th while the order on DA was endorsed and uploaded to the website the very next day of its issuance by the Department of Expenditure.

KP&TPA sent an email to the Additional Director General (Pension), Postal Directorate bringing to his notice about the delay in payment of arrears of DR to Pensioners because of the delay in uploading the OM to the website.

Sri Sathya Prakash Gupta, Secretary, Postal Pensioners Association Rajasthan, Jaipur spoke with the Additional Director General and strongly urged immediate action on the matter.

Finally, it turned out that the Postal Directorate had repeatedly instructed all Circles not to wait for endorsement of the DR orders by DO Posts but to download it from the website of DoPPW and effect payment.

Sri Gupta sent us a copy of the orders sent to him by the ADG. The relevant orders were issued by DO Posts on 25.6.2013 and 24.11.2024 instructing Circles to download the DOPPW OM from its website and effect payment.

Sri M B Shivalingaiah, Executive Committee Member, KP&TPA visited Channapatna H O to inquire about the delay in drawal of arrears of DR. He was informed by the accounts branch that while there is no problem in making off-cycle payments but the system needs updating with revised rates of DR.

Smt. Nagalakshmi, our Vice president, in spite of her busy schedule on the day, talked to the Asst. Director, CEPT Blore. to initiate action in the matter to allow payment of DR at revised rates.

In response, CEPT Blore updated the software system to allow payment of arrears of DR from July 25 at the revised rate and sent messages to all Drawing and Disbursing offices in the country stating that the rate of DR payable from July 25 has been updated. Thereafter, the HOs were enabled to draw arrears.

The Association will write to the CPMG to reiterate the instructions on the subject and to advise CEPT, BG to initiate action in accordance with the Directorates orders and not to wait for endorsement of the OM by DO POSTS

**Payment of Arrears of DR to Pensioners
DO Posts orders**

GoI, Ministry of Communications, Department of Posts (Pension Section) No. 4-1(28)/2024-Pension dated 26th November 2024 addressed to all Head of Postal Circles, CGM, BD, Parcel Directorate, PLI Directorate, all regional PMG, all Directors/ Dy. Directors of Accounts(Postal)

Implementation of Office Memorandum of Department of Pension and Pensioners' Welfare posted in Website for encashment of Dearness Relief for Pensioners/Family Pensioners

I am directed to inform that the Directorate is in receipt of letters from Pensioners' Associations and individual emails that orders of enhancement of Dearness Relief are not being implemented in some of the Circles on the ground that it is not circulated by the Directorate or some other reasons.

2. In this regard, It is intimated that vide letter No 100-9/2011-pension dated 25.06.2013(copy enclosed), all Heads of Postal Circles and others officers were intimated that the OM of Department of Pension & Pensioners' Welfare posted on its website for enhancement of Dearness relief for Pensioners/Family Pensioners may be given effect to by all the authorities/ officers concerned in the Department of Posts **without waiting for any separate Circular from the Directorate in the matter.**

3. In spite of aforesaid letter of the Directorate, some offices are not following the orders of the Directorate, due to which representations for non-receipt of DR are being received.

4. Therefore, It is reiterated that the Department of Pension & PW 's Office Memorandum for encashment of Dearness Relief to Pensioners/ Family Pensioners (uploaded on DoPPW's official website) may be given effect to by all authorities/ offices concerned in the Department of Posts **without waiting for any separate Circular** from the Directorate so that delay in compliance of the same is eliminated.

5. All Heads of Postal Circles may please issue necessary instruction to all the Offices under their jurisdiction to ensure strict compliance in this regard.

Implementation of OM of DoP& PW posted in the Pensioners Portal Website for enhancement of Dearness relief for Pensioners/Family Pensioners

I am directed to refer to this Division's Circular No. 100-13/2012-pen dated 11.10.2012 on the above subject (copy enclosed) and to say that it has been brought to the notice of authorities of the Department by DoP& PW that enhancement orders on Dearness relief are not being implemented by some offices in the Department of Posts on the basis of OM posted in the Pensioners' portal by DoP& PW.

2. It is reiterated that the OM of Department of Pension & PW posted in the Pensioners' portal for encashment of Dearness Relief from time to time for Pensioners/Family Pensioners, may be given effect to by all the authorities /offices

concerned in the Department of Posts **without waiting for any separate Circular of this Directorate for the purpose.** This will eliminate the delay in payment of enhanced Dearness Relief, which takes place on account of circulation of OMs from Directorate to Circles and below.

All Heads of Circles may issue suitable instructions to all the offices under their respective jurisdiction to ensure compliance in this regard.
