Sub: A request for migration to SAMPANN by Family Pensioner and allot Sampann PPO No. – Case of Kusumben Rajnikant Mahadik – PPO NO: TAC/FP/RBM/99-2000/71-8.

Sir,

1. We are perturbed to know that a Family Pensioner has to approach to your office for allotting her Sampann PPO Number,,, the work which should have been done automatically in a routine manner by your office, as the said PPO was issued during the DoT period, when employee was expired while in service on 27.01.1999 and the said PPO was issued.

2. As we understand the work of allotting Sampann number was initiated from the Pensioners drawing their pension from Bank and in this case it is Bank of India, where virtually all the cases have been allotted Sampann number since long time.

3. *Since the Bank of India R. V. Desai Road Vadodara had declined to accept Family Pensioner's physical DLC and advised to contact Pension Disbursing Authority, the need of her PPO's conversion to SAMPANN was felt by her in order to continue her pension without any disruption.*

4. Now coming to the issue, we furnish herewith the following details of the Family Pensioner has applied to your office vide her application dated 04.12.2025 (Copy Enclosed) for allotting her Sampann number and get the all the messages to her in time including the expiry date of her DLC. In support of her request, she has furnished the following documents with the application.

- 1) K.Y.C. Form with her photo and all the required details.
- 2) Aadhar Card for her DOB.
- 3) DLC generated with her bank details; which reads “Your Digital Life Certificate has been successfully accepted by Bank (Bank of India).
- 4) DLC generated with her old PPO No. and by furnishing PDA as Gujarat CCA, which says it will be subject to acceptance by your Pension processing Center SAMPANN.

She has also furnished copy of her PPO and Bank Account details, which we have enclosed with her physical application with all required details.

We, therefore, request your office to kindly allot her SAMPANN number at the earliest and inform her so that she can be relieved from her mental stress of continuation of her family pension and submitting her DLC in time to competent authority and also get all the pension related messages.
