In regards to the above it is to be Report here that:

1. There Were 2 (Two) Post and Telegraph Dispensaries Functioning at Vadodara Station, First at Raopura Area and Second in P&T Colony, Harni Road, Vadodara.

There were 3437 Card Holders and 12001 Beneficiaries in Vadodara P&T Dispensaries. Prior to Functioning of the Department of Bharat Sanchar Nigam Limited (BSNL) on 01-10-2000.

Consequently upon Receipts of New Medical Facility for BSNL employees and majority of Card Holders of BSNL have opted for the new scheme. The employees as well as the beneficiaries do not require facility of the P&T Dispensaries. Hence the number of Card holders and beneficiaries were reduced.

Therefore, Proposal for Re-organization of P&T Dispensaries was discussed in the meeting of the Postal Service Board held on 12-08-2005 and Ministry of Communications and Information Technology, Department of Posts had decided vide Deputy Director General (Estt.) letter No.-2-24/2003-Medical dated 07 October, 2005, Dak Bhavan, Sansad Marg, New Delhi for merger of 2 (two) dispensaries in to 1(one) at Vadodara.
