**DELAY IN IMPLEMENTATION OF CAT JUDGMENT.**

Sub: **A request to implement CAT Ahmedabad verdict in O.A. No.348/2017 dated 05.03.2026.**

Respected Sir,

1. We enclose here with a copy of CAT Ahmedabad O.A.No.348/2027 judgment delivered on 5<sup>th</sup> March, 2026 admitting the prayer made before the Hon'ble CAT Ahmedabad by 18 Applicants.
2. We reproduce the operative portion of the judgment as under:  
"11. In view of the above, the OA is partly allowed. The respondents are directed to consider the benefits of grant of one extra increment in BCR Grade-III one year prior to retirement the one extra increment should be treated as part and parcel for calculation of pensionary benefits. Further, in case the applicants are not paid the pension amount reckoning the increment so granted the same shall be revised and paid deducting the actual amount paid, as early as possible, preferable within 90 days months from the date of receipt of the certified copy of this order. It is made clear that any arrears, if payable to the applicants, the same shall be paid w.e.f. the date of filing of the OA i.e. 24.04.2017. It is expected that within 90 days from the receipt of a certified copy of this order, the respondents shall complete their exercise as directed hereinabove and intimate the decision forthwith."
3. As per the orders as cited above, all the applicants and family pensioners are eligible for the pensionary benefits of one extra increment which was already sanctioned and the pensionary benefits were also paid but later on recovered.

4. Out of 18 applicants, ten applicants have applied for the implementation of the said judgment and consequential benefit w.e.f. 24.04.2027 from the date of authenticated true copy which was issued on 19.03.2026.
5. As per Para 8 and 10 of the judgment, Family Pensioners are also eligible for the benefit and accordingly Five Family Pensioners have also applied.
6. We furnish below the list of applicants/family pensioners, who have already applied to the office of the Pr. G.M.T.D. Ahmedabad on 1<sup>st</sup> April, 2026 but till date their cases are not forwarded to the CCA for considering pensionery benefits and also to pay the pensionery benefits as decided by the CAT Ahmedabad.

7. For your kind information, your office had already considered extra-increment for pensionary benefits and already paid. Later on, your office had recovered the said benefit.



We therefore request you kindly give your approval and ensure the justice to the pensioners who are struggling since long for their legitimate demand.
