- Costs of administration, printing, travel, legal representation and other services are continuously rising.

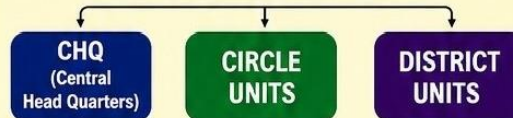
