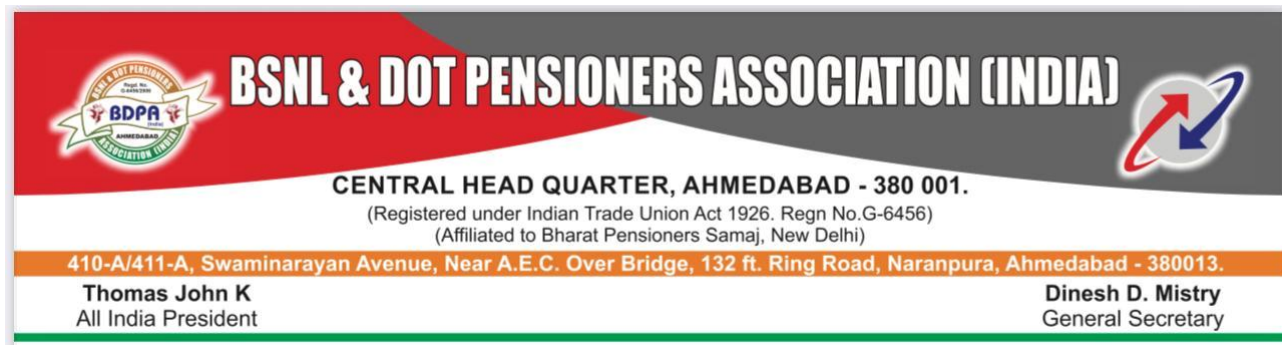

GENERAL CIRCULAR

SUBJECT: COLLECTION OF ANNUAL MEMBERSHIP SUBSCRIPTION OF ₹300/- PER MEMBER WITH EFFECT FROM 01.01.2026

Dear District/Circle Secretaries & CHQ Office Bearers,

As all of you are aware, certain amendments to the Constitution of our Association were notified vide **Notification No. BDPA(I)/5th AIC/2026 dated 06.03.2026**. These amendments were placed before and discussed at the **5th All India Conference of BDPA (India), held at Hyderabad on 8th and 9th April 2026**, and were **approved unanimously by the Conference**.

The approved amendments were thereafter forwarded to the Office of the Labour Commissioner, Gandhinagar on **21.04.2026** and, after due scrutiny and follow-up, the amendments were approved on **14.08.2026** in accordance with the applicable provisions of the Labour Rules.

Among the amendments, **Clause 9 relates to Membership Subscription**. The revised provisions provide, inter alia, as follows:

- a. **Admission Fee:** ₹100/-, to be remitted to the Central Head Quarters, Ahmedabad.
- b. **(b) Initial Membership Subscription:** ₹900/-, comprising ₹300/- for CHQ, ₹350/- for Circle and ₹250/- for District.
- c. **Annual Subscription from the succeeding year:** ₹300/- per member per year, to be equally shared as ₹100/- each by CHQ, Circle and District.
- d. **Donations:** Donations may be collected on special occasions as and when required.

REGULAR COLLECTION OF ANNUAL SUBSCRIPTION – AN APPEAL TO ALL DISTRICT SECRETARIES

The above constitutional amendment has now provided a clear and uniform system for the financial functioning of the Association at all three levels—**Central Head Quarters, Circles and Districts**.

The strength of any organization depends not only upon its membership but also upon the **regular financial participation of every member**. Our Association has to meet recurring expenditure for maintaining organizational activities, correspondence, communication, meetings, welfare work, representations before various authorities, legal and administrative follow-up, and coordination of activities at different levels.

The annual subscription of **₹300/- per member works out to only ₹25/- per month**, yet its regular collection from every member will provide a dependable financial foundation for the Association and enable all three levels to discharge their responsibilities effectively.

We therefore make a **sincere and fervent appeal to every District Secretary** to give this matter personal attention and ensure that the annual subscription of **₹300/- per member, with effect from 01.04.2026**, is collected regularly from all members of the District.

District Secretaries are requested to treat this not as a routine collection exercise but as an **organizational responsibility and a collective contribution towards strengthening our own Association.**

REMITTANCE AND DETAILS OF MEMBERS:

The amount collected should be properly accounted for and the respective shares should be remitted promptly to:

- **₹100/- per member – Central Head Quarters, Ahmedabad**
- **₹100/- per member – Concerned Circle**
- **₹100/- per member – Concerned District**

While remitting the subscription, the details of each member should invariably be furnished in a clear statement containing:

Membership No. | Name of Member | Station | District | Amount

This will ensure proper accounting, reconciliation and maintenance of updated membership records at CHQ, Circle and District levels.

District Secretaries are requested to **avoid accumulation of subscription for long periods** and to arrange remittance of the respective shares regularly, so that the financial position and membership records of every unit remain updated.

A COLLECTIVE RESPONSIBILITY:

Friends , our Association has grown through the dedication, sacrifice and continued support of its members. The revised subscription is modest, but **regularity and discipline in its collection are vital for the strength and independence of our organization.**

We therefore earnestly request all District Secretaries, Circle Secretaries and office-bearers to extend their full cooperation and ensure that every member contributes his or her annual subscription regularly.

A strong organization requires not only unity in our demands but also discipline in fulfilling our organizational responsibilities.

Let us therefore make the collection of the annual subscription of **₹300/- from every member, w.e.f. 01.04.2026, a regular and well-organized practice** and thereby further strengthen BDPA (India) at the District, Circle and Central levels.
